CHIEF LESCHI SCHOOLS APPLICANT DISCLOSURE

In accordance with RCW 43.43.830, applicants and perspective volunteers are required to complete this disclosure form.

Volunteers will be retained on the same conditional basis. A copy of the State Patrol's response will be sent to the employee/volunteer within ten days after receipt by the school.
